From celebrating with our ten-year anniversary in February, to moving in July, to hosting another successful Bark and Wine and then organizing our most successful end-of-year campaign to date, the year just flew by. Despite that, we also managed to achieve another year of record-breaking adoptions as well. It never ceases to amaze me how much work can be done and what a big difference a small group can make when it has the love and power of a community behind it.
